

**MYSPACE JUMP TO YOUR TOP FRIEND GAME OF SKILL PROMOTION.
TERMS & CONDITIONS.**

1. Information on how to enter forms part of the terms and conditions of entry to this game of skill promotion. Entry into the promotion is deemed acceptance of these terms and conditions.

9. There is 1 Major and 20 Minor prizes.

The Major Prize is a trip for up to 2 people to anywhere in the world to a maximum value of \$8,000. Where the nominated Top Friend is an Australian resident both persons are able to jump to a common destination.
