

**MYSPACE RECHARGE/WIN TICKETS TO SEE BRITNEY LIVE IN CONCERT
TERMS & CONDITIONS**

Information on how to enter form part of these conditions of entry. Participation in this competition constitutes acceptance of these terms & conditions of entry.

- 1) Entry is open to all permanent residents of Australia aged 13 years or over. Employees, directors and management of the Promoter or of the agencies or companies associated with the competition and the immediate families of these persons are ineligible to enter.
- 2) Competition commences on 1 September 2009 at 12.01am AEST and closes on 14 October 2009 at 11.59pm AEST (Promotional Period).
- 3) To enter, Eligible Entrants must, during the Promotional Period, sign up for and activate their MySpace Recharge Prepaid Card and be a registered MySpace User.
A registered MySpace User must:
 - a) Sign Up to become a MySpace user OR login if the entrant is already a member at MySpace.com
 - b) sign up for and activate their MySpace Recharge Prepaid Card

Entry is via online at MySpace.com; all entries must be submitted online and received by the Promoter during the Promotional Period.
