**“So You Think You Can Dance Sweepstakes”  
Official Sweepstakes Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW.**

The following promotion is intended for participants in the United States only and shall be construed and evaluated according to the laws of the United States. Do not proceed in this promotion if you are not a legal resident of the United States. Further eligibility restrictions are contained in the official rules (“**Official Rules**”) below.

**1. DESCRIPTION:** The “So You Think You Can Dance Sweepstakes” (“**Sweepstakes**”) begins on June 15, 2011 and ends on July 7, 2011 at 12:00 PM Pacific Time (“**PT**”) (“**Sweepstakes Period**”). The Sweepstakes is sponsored, administered and fulfilled by Myspace, Inc., 407 North Maple Drive, Beverly Hills, CA 90210 (“**Sponsor**” or “**Myspace**”), and is presented by Fox Broadcasting Company, 10201 W. Pico Blvd., Los Angeles, CA 90035 (“**Presenting Sponsor**” or “**Prize Provider**”). The Sweepstakes shall be subject to these Official Rules, and by entering the Sweepstakes, all entrants represent and warrant that they have read these Official Rules and agree to be bound by the terms and conditions herein.

**2. HOW TO ENTER:** Entrants must visit <http://www.Myspace.com/danceonfox> (“**Website**”) during the Sweepstakes Period. Entrants will be instructed to follow the on-screen instructions to post a comment (“**Submission**”) based on the question or prompt associated with the Sweepstakes. By responding to the Sweepstakes question or prompt (i.e., “What does it take to become America’s Favorite Dancer?”), the Entrant will automatically receive one (1) entry into the Sweepstakes. Submission must NOT contain material which is (or promote activities which are) sexually explicit, obscene, pornographic, violent, self-mutilating, discriminatory, illegal (e.g., underage drinking, substance abuse, computer hacking, etc.), offensive, threatening, hateful, tortuous, defamatory, slanderous, libelous, profane, harassing or material that contains any derogatory references to the Sponsor, Presenting Sponsor, the “Sweepstakes Entities” (as defined below) or the series “So You Think You Can Dance”(including, but not limited to, its cast and crew members). Submissions must be received by July 7, 2011 at 12:00 PM PT to be eligible for the Sweepstakes. Submissions which violate any of these requirements may be deemed ineligible to receive the prize and the Submission may be void at the Sponsor’s sole discretion. Sponsor reserves the right to disqualify any Submission deemed inappropriate or that does not comply with the Website’s Terms of Use. Incomplete or unintelligible entries will be disqualified. Sponsor reserves the right to determine which entries have satisfied the entry requirements, in its sole discretion. Entries generated by a macro, script or other automated means will be disqualified. Each entrant must be the rightful owner (or have authorized use) of the Myspace account utilized in the Sweepstakes. In the event of a dispute as to the identity of any entrant or winner, at the sole discretion of the Sponsor, the entrant or winner will be deemed to be the person in whose name the Myspace account was opened. Incomplete, unreadable, or unintelligible entries will be disqualified. Entrants must provide all information requested to be eligible to win. There will be no notification of receipt of Sweepstakes-related materials. Assurance of delivery of Submissions will be the sole responsibility of the Entrant.

**3. ELIGIBILITY:** Sweepstakes is open to legal residents of the fifty (50) United States and Washington, D.C. who are between the ages of thirteen (13) and thirty-five (35) years of age in their state of primary residence at time of entry (“**Entrant**”). Eligible Entrants who are under the legal age of majority in their state of primary residence (“**Minor**”) must get their parent or legal guardian’s permission to participate. A Minor Entrant will be required to provide parental consent in a form satisfactory to the Sponsor before he or she can be declared a winner and any prize can be awarded. Entrants must

have Internet access or otherwise have an ability to access the Internet as of the start date. All entrants must be registered members of the [www.Myspace.com](http://www.Myspace.com) website ("**Myspace Member**") and in compliance with Myspace's Terms & Conditions policy located at <http://www.Myspace.com/index.cfm?fuseaction=misc.terms> which may be modified from time to time. Any individuals (including but not limited to employees, independent contractors, consultants and interns) who have, within the last six (6) months, been employed by or performed services for Sponsor, Presenting Sponsor, 19 Entertainment, Dick Clark Productions, Dane Nations Productions, Inc., or any organizations affiliated with the administration, prize support, fulfillment, advertisement or promotion of the Sweepstakes (collectively, "**Sweepstakes Entities**") are not eligible to enter or win. Household Members and Immediate Family Members of each such individual are also not eligible to enter or win. **4. PRIZE:**

Prize (1)	<p>One (1) Grand Prize winner ("Winner") will receive a trip to Los Angeles, CA (the "Trip") to attend a taping of "So You Think You Can Dance" (the "Taping"). Trip includes roundtrip coach air transportation for two (2) from the major U.S. gateway airport nearest winner's residence to Los Angeles, CA, two (2) nights hotel accommodations (as determined by Sponsor) (standard, double occupancy), ground transportation to and from airport to the hotel, and to and from the hotel to the Taping, plus a gift card in the amount of \$250.00. Estimated retail value of all prizes is \$2,250.00. Actual value may vary depending on location of winner's residence. Winner and travel companion agree that they undertake the Trip at their own risk. Winner and travel companion must travel together on the same itinerary, including the same departure date, destination and return date and must have valid travel documents (e.g., valid government issued photo ID and/or Passport) prior to departure. Failure to do so will result in forfeiture of prize. Travel companion (or parent/legal guardian if a minor) must complete a travel guest liability/publicity release prior to the Trip. **TRAVEL IS TENTATIVELY SCHEDULED TO TAKE PLACE BETWEEN JULY 19 and JULY 21, 2011.** Exact Trip dates will be specified by the Sweepstakes Entities. Failure to travel on the dates specified by the Sweepstakes Entities may result in forfeiture of the prize. All prize details are at the sole discretion of the Sponsor. Prize winner cannot assign or transfer the prize to another person. Cash alternative is allowed at the sole discretion of Sponsor. If a prize cannot be

awarded due to circumstances beyond the control of Sponsor, a substitute prize of equal or greater retail value may be awarded. If winner cannot accept a prize, or any portion thereof, as stated, the prize may be forfeited at the sole discretion of Sponsor. The value of the prize represents Sponsor's good faith determination of the maximum retail value thereof. No refunds or credit for changes are allowed. Potential winner will be notified by email and their Myspace profile, at the sole discretion of Sponsor, within approximately seven (7) days of the drawing date. Selected potential winner will be required to respond (as directed by the Sponsor) to the notification. The failure to respond timely to the notification may result in forfeiture of the prize and the Sponsor will randomly select an alternate potential winner from among the remaining eligible entries for that prize. Potential winner may be required to verify address and return within five (5) days (or a shorter time if required by exigencies) an affidavit of eligibility, a liability release, and, unless prohibited by law, a publicity release (collectively, the "**Prize Claim Documents**") covering eligibility, liability, advertising, publicity and media appearance issues.
